# **AL 09/25 TENANCY AGREEMENT UPDATES**

To consider and approve in principle the below updates to the tenancy agreements;

- a) Tenants wishing to plant fruit trees:-
  - Shall not plant any trees on the allotment without the prior written consent of the Council;
  - May only plant dwarf fruiting trees and other fruiting bushes;
  - Must not cover more than 25% of their plot;
  - Must not plant along the boundaries of their plot;
  - Are responsible for the continued maintenance and pruning for the length of tenancy to prevent them becoming a nuisance;
  - Any plants deemed to be a nuisance are at risk of being removed at the cost of the tenant.
- b) Dogs on Site; Informal agreement to not ban dogs completely, but they must be controlled and contained to owner's plot.
- c) Gravel Footpaths; Footpaths must be biodegradable or easily removable at the end of the tenancy, non-compliance could result in the deposit being withheld.
- d) General Number 10; Any notice to be served on any tenant shall be given via email or hand delivered to the last notified address to the parish clerk (tenants are advised to notify the clerk of any change of address)

Failure to comply with the legislation in relation to disclosable pecuniary interests is a criminal offence, subject to a maximum fine of £5,000 and/or disqualification from being a councillor for up to 5 years.)
